Artist Solicitation

The City of Clemson invites artists to submit applications for their art or design to be utilized to wrap existing metal traffic boxes at selected traffic signal boxes across the city.

Artwork will be approved by city staff and will be presented anonymously. Artwork will be printed on vinyl wraps and applied to selected traffic signal boxes. Art will remain on the signal box for 12 months.

Art will be accepted on a rolling basis. One application per artist.

Artist Benefit

1. Artists will receive a \$250 stipend paid by The City of Clemson.
2. Artist recognition.
3. Mention on the arts center website and social media.
4. The Arts Center will create a pamphlet of the traffic signal box art that will include artists' bios and links to more artist information.

Design Specifications

1. Designs must be original and wholly the work of the submitting artist.
2. Designs must be print ready digital submissions. Accepted files are JPG or PNG and must be at least 150 DPI.
3. Designs may not include text of any kind (except the required text), (trademarks, brands, or advertising of any sort).
The artwork should be appropriate for general viewing. No political, religious or sexual symbols, themes or messages. The City of Clemson reserves the right to refuse any designs.
4. Designs may be traditional, representation or abstract.
5. See attached template for sizing reference.
6. Design should flow across all faces of the box and reflect a unified work of art.
Depending on your artwork size specs and subject matter placement, images may need to be cropped in order to fit.
7. The City of Clemson staff will have final approval of the design.

Eligibility

1. Artists must be at least sixteen years of age.
2. Artists must reside in South Carolina

Terms of Agreement

1. The artwork submitted is original, solely owned by the artist, and reproduction will not violate the rights of any third party.
2. The City of Clemson retains the right to use accepted artwork presented for this project and to use prints/photos of the art for promotional material. The City of Clemson may not sell the art to a third party for profit.
3. The City of Clemson has the right to remove or replace the art without notification to the artist.
4. There will be a SCDOT required sign placed on the upper right corner of the back panel.

Release Waiver

The undersigned artist, a participant in the City of Clemson Signal Box Art Program, does hereby indemnify, release, discharge and hold harmless the City of Clemson or its agents, servants, employees or attorneys, through the artist's participation in said project and the use of his/her artwork of any and all actions, causes of action, demands, suits, accounts, covenants, damage claims, and any and all claims, demands and liabilities for loss, harm or damage whatsoever of every name and nature, both in law and equity, which may be brought against the City of Clemson
